

OBJECT: Information pursuant to Article 13 of EU Regulation No. 679/2016

In accordance with the provisions of Article 13 of European Regulation 679/2016, we would like to inform you of the following:

Purpose of the processing:

Your personal data, freely communicated and acquired by us during the activity carried out by ESTALIA PERFORMANCE COATINGS SPA, will be processed lawfully and fairly for the following purposes:

- Administrative-accounting in the management of the school relationship and/or in the provision of a service.
- Other purposes are traced to promotional activities, marketing, and newsletters.

The data processed (which may be of both common, identifying, sensitive, and judicial nature) are up-to-date, relevant, complete, and not excessive in relation to the purposes listed above for which they are collected and subsequently processed.

Method of processing:

Your data will be processed, in compliance with the necessary security and confidentiality, through the following modalities: collection of data from the subject, collected and recorded for specific, explicit and legitimate purposes and used in further processing operations in ways that are consistent with these purposes, processing carried out with the help of electronic and automated tools (data collection by electronic means, directly from the data subject).

Legal basis of processing:

The legal basis for the processing of your personal data is based on the signing of the contract, on the proposal or on the offer submitted by us to you or vice versa. On your request for information or offers about our products or services.

Legitimate interests pursued by the Data Controller:

The legitimate interests pursued by the Data Controller in the processing of data are given by having to respect and honor the contractual obligations signed between the parties or comply with their requests. Pursuant to Article 6, the lawfulness of processing is based on the manifestly expressed consent of the data subject, documented in writing.

Compulsory or optional nature of data provision and consequences of refusal to respond:

The nature of the provision of administrative accounting data by you is mandatory for the Data Controller to be able to provide the services requested. In case of refusal, it will therefore be impossible to proceed with the relationship and the Data Controller will not be able to fulfill its contractual obligations.

On the other hand, the provision of data for advertising and information purposes is not mandatory and derives from any explicit consent that may have been given.

Communication of data to third parties:

Your personal data will be processed by the Data Controller, by the Data Processors appointed by him/her and by strictly authorized data processors. It may be communicated to institutional bodies in the event of a request by them.

Your data may be communicated as a result of inspections or audits (if requested), to all inspection bodies in charge of audits and controls inherent to the regularity of legal compliance.

Your data may also be communicated to companies/professional firms that provide assistance, advice or collaboration to the data controller, in accounting, administrative, fiscal, legal, tax and financial matters, to public administrations for the performance of institutional functions within the limits established by law or regulations and to third party service providers to whom the communication is necessary for the fulfillment of the services covered by the contract. Your personal data will not be disseminated in any way.

Retention periods:

Your personal data will be kept for nr. 10 (ten) years, from the termination of the relationship or until the business purposes are achieved.

Existence of automated decision-making process:

There is no automated decision-making process.

Intention of the Data Controller to process personal data:

The Data Controller will not transfer your personal data to a third country or international organization.

Data Controller and Data Processor:

The Data Controller is ESTALIA PERFORMANCE COATINGS SPA, in the person of the Legal Representative.

The Data Protection Officer designated for feedback to the data subject in case of exercise of rights is Dr. Marco Bentivoglio.

The interested party may at any time exercise the rights reserved to him, enshrined in Art. 15, the full text of which is given below.

Article 15 EU Regulation 679/2016 - Right of access to personal data and other rights -

The data subject shall have the right to obtain confirmation as to whether or not personal data concerning him/her exist, regardless of their being already recorded, and communication of such data in intelligible form. The interested party has the right to obtain information on the origin of the personal data; on the purposes and methods of processing; on the logic applied in the case of processing carried out with the aid of electronic instruments; on the identification details of the data controller, the data processor and the representative appointed in accordance with art. 5 paragraph 2; on the subjects or categories of subjects to whom the personal data may be communicated or who may become aware of them as appointed representative in the territory of the State, managers or agents. The interested party has the right to obtain: the updating, rectification, or, when interested, the integration of data; the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those that do not need to be kept for the purposes for which the data were collected or subsequently processed. The data subject has the right to object in whole or in part: on legitimate grounds to the processing of personal data concerning him/her, even if pertinent to the purpose of collection; to the processing of personal data concerning him/her for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication. In particular, the data subject may at any time request the Data Controller for the access to personal data and the rectification or deletion of the same or the restriction of processing concerning him or her or object to its processing, as well as the right to data portability. The data subject has the right to revoke consent at any time without affecting the lawfulness of the processing based on the consent given before revocation and has the right to lodge a complaint with a supervisory authority.
